1. Get together and lunch

After welcoming the participants and presenting the agenda of the meeting, Michael informed the attendees that the takeover of Phadia through Thermo Fisher Scientific will not influence the collaboration between the new company and the EASI network. Phadia builds now the new ImmunoDiagnostics Division of Thermo Fisher Scientific and will continuously fully support EASI.

2. Status of the EASI Projects

a. Booklet for Family Doctors

The preparation of the booklet is finalized. All chapters have been prepared.

To update those chapters which have been sent a long time ago, Nina will send the chapters back to the authors. Please, update the references so that at least one of them is from 2010 or 2011. Please, make sure too that only 5 references will be included.

Please, send the chapters back to Nina (<u>nina.olschowka@thermofisher.com</u>) not later than Sunday, October 16.

The chapters will be finally reviewed by Yehuda Shoenfeld and thereafter sent to the publisher for publication.

Aim is to distribute the booklet at the Granada Congress in May 2012.

b. EASI ANA surveys in Europe (ANA questionnaire I to Laboratory Specialists; ANA questionnaire II to Clinicians)

A summary of the collected data for the ANA Laboratory Survey has been presented by Nina (see presentation attached).

Unfortunately, not all EASI countries have performed this survey so far. All the countries are invited to complete the evaluation of this ANA Laboratory Survey to get a most complete picture of the European situation. Nina and Jan will collect and summarize all the data from the different countries and Jan will present the data at the Granada Congress in May 2012. Furthermore, it is planned to write a publication. Of course, this is only interesting when most of the European countries are involved.

A second ANA questionnaire for Clinicians has been created by the EASI groups in Portugal and Finland. Also here, all other countries are invited to participate in this survey too. Again, the more countries will use this questionnaire the better the information we can gather about the usage of ANA in clinical practice in Europe and the more attractive are the data for follow-up projects and publication.

Both questionnaires are attached to this protocol.

To enable a final analysis of the data on a national and European level, the questions of both questionnaires should not be modified.

If you like to shorten the questionnaire, the number of questions in the questionnaire can be reduced. If countries would like to have more information about their countries, questions might be added individually.



3. Positioning paper of the EASI Steering Group together with the EASI Forum how CTD Diagnosis should be supported in Europe

Nancy presented the analysis of the discussion about the ACR recommendation and the comments most EASI countries have given to the statement paper Nancy, Jan, Pier-Luigi and Yehuda have sent (see original statements and presentation attached to this report).

For different reasons, not all EASI countries have participated in the discussion about the recommendations, yet. The missing countries are asked to send their comments as soon as possible to Nancy (nancy.agmon-levin@sheba.health.gov.il).

Some open issues which need to be solved before a final paper can be prepared, were highlighted. It is required to discuss these issues more in detail and find a final agreement.
